[Book of common Prayer] & administering the Lords Supper to Popish & Prelatic persons of other counties, cringing, bowing, & kneeling to the Altar & Sacrament thus proved contrary to the Ordinance of Parliament in that case provided. John Allington said He would be torn in pieces by wild horses before he would give over bowing at naming Jesus. Mr Spriggs succeeded J.A. [John Allington] turning his wife & children into the town street. J.A. [John Allington] lived till after the Restoration. Mr Spriggs prayed 'O Lord get up on Thine horse & make haste unto [??] land or Thou will lose more honour there than ever Thou gottest in England.

A faculty is therefore issued to build a new substantial & convenient house at Belton on the Home Allotment of glebe there: especially as there is supposed to be a bed of clay on this Home Allotment suitable for making brick tile & [pc?]: a Commission made up of Wm Baker R [Rector] of Lyndon, Wm Forster R [Rector] of Ayston Hy Shield R [Rector] of Preston, Geo Pywell & Wm Kemp of Belton espy [especially?] recommend the demolition of the Recty ho. [Rectory house] & its buildings at Wardley as well as the cottage, & the building of a new house of residence at Belton. Faculty issued accordingly.
