1625	Nov 10	Ffrancis Meeres the R [Rector] for attempting the chastity of <u>Katharine Allin</u> his late maid servant as the same fame goeth. Mr F. Meeres R [Rector] for neglecting to preach so often in our parish church as by law he is bound. Robt Mason for wrangling & brawlinge in the churche. Mr Meeres R [Rector] for not reading the booke of Canons within these 12 monthes last past as by law he ought
1628	Jun 12	There is a common fame that the sd [said] Ffosbrooke was incontinent with the sd Rebecca Allin - A 4 hand purgacon [?] ordered
1628	Jun 28	Thos Allin jun [junior] for lyeinge very unquietly, very ungodly, ungraciouslye and unrighteously with his wife. Also Andrew Bunnige
1628	May 13	Rich Fosbroke q <sup>th</sup> these letters look similar to g <sup>+</sup> above 1608 July 16 where they could be an abbreviation for 'granted' but that doesn't seem likely here or in the next entry Thos Allin & Rebecc his wife. Slander

1628	May 27	Andrew Bunninge for a cryme of a <b>sclander [slander]</b> betwixt his wife and him - Clemen is the wife's name. Richard Ffosbrooke A crime betwixt Rebecca Allin & him. Rebecca Allin states that the said Ffosbrooke beinge a Carpenter wanted timber to make Ruddle staves, whereupon the <b>sd [said]</b> Rebecca went up into her Chamber for stuffe to make Ruddle staves withal & the <b>sd [said]</b> Ffosbrooke followinge her up into the Chamber he the <b>sd [said]</b> Ffosbrooke did then kiss her & did put his hand under her Apron.

[London]</b> 1598 (Pt 1 by <b>NL - don't know who this refers to</b> ); God's Arithmetic or the whole requirement of Xtn life, 1614. The Devotions of Luis of Granada translated into English 1595. He was the grandfather of Robt Meres D.D. Chancellor of Lincoln
1717	Mar 26	Sutor ag Baines suit of defamation
177#	ND	Baptist Noel Turner, also <b>R [Rector]</b> of Denton, Grantham 16 miles from Wing
1820	Dec 19	Faculty issued for repair of Pulpit, Reading Desk to be newmade and placed suitably. Seats and Pews to be totally newmade: the Pavement to be relaid: the old pews sittings desk and pulpit being very dilapidated & inconvenient. A plan of the church is annexed with a list of 30 families to whom the 30 pews are assigned: W Gilson, Warden
