- Henry Nellam a common drunkard hustling James servant of John Waterfall for pushing one John Robinson out of his seat in the church in the time of divine service and did cast him to the ground
- Jan 7. Thomas Noble for keeping on the Sabothe day in prayers time company with an excommunicate person
- Mar 13. Thos Clarke, Rich. Osborne, John Bampton, Michael Cooper, Henry Hunt, William Neale, each fined 3<sup>s</sup> 4<sup>d</sup> for keeping Company with Henry Nellam being an excommunicate person
- 1615 Apr 20. William Wright that he kept company with Henry Nellam being excommunicate.
- May 10. Thomas Noble for incontinency with two strange women who frequent the house of one Henry Nellam as the coum. or faine goeth. And also the churchwardens found them together in suspicious manner in the same house on the Sabothe daye in service time about Candlemas last past
- Thomas Noble for dryinge of lambskins on the Sabothe daye about Midlent last past - fined 10<sup>s</sup> 10<sup>d</sup> on Sept 30.
- John Watson servant of Noble, accused on a like charge, states that his master and he did laye out lambskins upon the Saboth day. but saith that it was upon necessity and that yff they had not honge them oute the lambskins would have bin loste.
